Counsellor of the Lisbon Institute of Sinology (Instituto de Sinologia), Jean-Philippe Béja is a member of the editorial boards of East Asia: An International Journal (New Jersey), Journal of Contemporary China and Chinese Cross Currents (Macau). He works on State-society relations in the People's Republic of China, and particularly on the Chinese pro-democracy movement. Among his works published in English, he edited The impact of China's Tiananmen massacre (London & New York: Routledge, 2011) < www.routledge. com/9780415578721> and with Fu Hualing and Eva Pils, Liu Xiaobo, Charter 08 and the challenges of political reform in China (Hong Kong: Hong Kong University Press, 2012). He also presented Liu Xiaobo's works in French in: Liu Xiaobo, La philosophie du porc et autres essais (Paris: Gallimard, 2011). His most recent article "Xi Jinping's China: on the Road to Neo-totalitarianism" was published in Social Research: An International Quarterly (Johns Hopkins University Press), Vol. 86, No. 1, Spring 2019, pp. 203-230. Michel Bonnin, Ph.D., is Professor Emeritus at the École des Hautes Études en Sciences Sociales (EHESS), Paris. Since his retirement in 2015, he has taken a post of Adjunct Professor at the Chinese University of Hong Kong, where he teaches the History and Memory of the Chinese Cultural Revolution. After studies in Philosophy and Chinese in Paris, he came to Hong Kong where he spent six years in the 1970s. During his stay, he met and interviewed a group of Chinese educated youth who had illegally swum across to Hong Kong. In the 1980s, he wrote a thesis on the topic of the Rustication movement and obtained his Ph.D. at the EHESS, where he was employed. From 1991 to 1998, he came back to Hong Kong and was the founding director of the French Research Centre on Contemporary China and of the magazine China Perspectives. In 2004, he published in French a book giving a global presentation of the Rustication movement of China's educated youth, which has been well received in the academic community and beyond. It had two Chinese editions published in Hong Kong and Beijing and an English edition entitled: The lost generation: The Rustication of China's educated youth (1968-1980) ("Choice Outstanding Academic Title, 2014"). His main research interests are the social and political issues in the People's Republic of China. He has written extensively in French, English and Chinese on the Cultural Revolution and especially on the Rustication movement of urban educated youth during the 1960s and the 1970s. He has also published books and articles on the democratic movements in China (Democracy Wall Movement and Tiananmen Movement), on contemporary Chinese history and collective memory as well as on the issue of generations in contemporary China. < Email: bonnin@ehess.fr, michel.bonnin@gmail.com>

Joseph Yu-shek Cheng, Ph.D., Honorary President of the New School for Democracy (華人民主書院), was formerly Chair Professor of Political Science and Coordinator of the Contemporary China Research Project, City University of Hong Kong. Before he joined the CityU in July 1992, Joseph Cheng taught at the Chinese University of Hong Kong (1977-1989) and the Open Learning Institute of Hong Kong (1989-1991). During 1991 -1992, he was a full-time member of the Central Policy Unit, Government of Hong Kong. He is the founding editor of the Hong Kong Journal of Social Sciences and The Journal of Comparative Asian Development. Joseph Cheng holds a Ph.D. from the Flinders University of South Australia, B.A. from University of Wellington, New Zealand, and B.Soc.Sc. from the University of Hong Kong. He has published widely on the political development in China and Hong Kong, Chinese foreign policy, local government in southern China and international relations in the Asia-Pacific region. In recent years he has edited Guangdong: Challenges in development and crisis management (2010), Whither China's democracy? Democratization in China since the Tiananmen Incident (2011), A new stage of development for an emerging superpower (2012) and The second Chief Executive of Hong Kong SAR: Evaluating the Tsang years 2005-2012 (2013), and his latest authored books are China's Japan policy: Adjusting to new challenges (2015), China's foreign policy: Challenges and prospects (2016), Multilateral approach in China's foreign policy (2018), and The development of Guangdong: China's economic powerhouse (2018). He was chairman of the Hong Kong Observers (1980-1982) and convener of Power for Democracy (2002-2004). He has been a Justice of Peace since 1992 and was the founding president of the Asian Studies Association of Hong Kong (2005-2007). During 2006-2008, he served as the secretary-general of the Civic Party. He was involved in the

Larry **Diamond**, Ph.D. (Stanford University, 1980), is Professor of Sociology and Political Science at Stanford University, and a senior fellow at the Hoover Institution and at the Freeman Spogli Institute for International Studies. During 2002–03, Diamond served as a consultant to the US Agency for International Development (USAID) and was a contributing author of its report *Foreign aid in the national interest*. He has also advised and lectured to universities and think tanks around

the world, and to the World Bank, the United Nations, the State Department, and other governmental and nongovernmental agencies dealing with governance and development. During the first three months of 2004, Diamond served as a senior adviser on governance to the Coalition Provisional Authority in Baghdad. His 2005 book, Squandered victory: The American occupation and the bungled effort to bring democracy to Iraq, was one of the first books to critically analyze America's postwar engagement in Iraq. For more than six years, he directed FSI's Center on Democracy, Development, and the Rule of Law, where he now leads its Program on Arab Reform and Democracy and its Global Digital Policy Incubator. He is the founding coeditor of the Journal of Democracy and also serves as senior consultant at the International Forum for Democratic Studies of the National Endowment for Democracy. He writes a monthly column for *The American Interest* and frequently consults on policies and programs to promote democracy. He directed the Stanford Program on Democracy in Taiwan for more than ten years and has been a regular visitor to Taiwan since 1995. Diamond's research focuses on democratic trends and conditions around the world and on policies and reforms to defend and advance democracy, and he has edited or coedited more than forty books on democratic development around the world. His forthcoming book, Ill winds: Saving democracy from Russian rage, Chinese ambition, and American complacency, analyzes the challenges confronting liberal democracy in the U.S. and around the world at this potential "hinge in history", and offers an agenda for strengthening and defending democracy at home and abroad. He is now writing a textbook and preparing a massive open online course (MOOC) on democratic development. Diamond's other books include In search of democracy (2016), The spirit of democracy (2008), Developing democracy: Toward consolidation

(1999), Promoting democracy in the 1990s (1995), and Class, ethnicity, and democracy in Nigeria (1989). Among his edited books are Democracy in decline?, Democratization and authoritarianism in the Arab world, Will China democratize?, and Liberation technology: Social media and the struggle for democracy, all edited with Marc F. Plattner; Politics and culture in contemporary Iran, with Abbas Milani; and the Hoover Institution report China's influence and American interests: Promoting constructive vigilance, released in November 2018, with Orville Schell. Perry **Link**, Ph.D. (Harvard, 1976), is Emeritus Professor of East Asian Studies at Princeton University and Chancellorial Chair for Teaching across Disciplines at the University of California, Riverside, and is known as one of the West's leading experts on China, its language, culture and people. With Andrew Nathan, he edited *The Tiananmen papers*, a collection of documents leaked by a high-level Chinese official that helped chronicle the events that led up to the June Fourth massacre. Nguyễn Quang A, Ph.D., is an activist, a scholar and a former bussinessman. He is co-founder and one of co-ordinators of Civil Society Forum, an informal (not registered) civil society organization in Vietnam. He obtained degree of Master of Science from Technical University of Budapest, Hungary, in 1971, a Ph.D. degree from Hungarian Academy of Sciences in 1975. After returing to Vietnam Dr Nguyễn Quang A was a researcher at the Military Reseach Institute,

then a civil servant at the General Directorate of Electronics and Informatic of Vietnam. He left the government service to became a CEO of Genpacific, a joint venture doing software outsourcing and computer business in 1988. He was one of the founders and the chairman of 3C computer service company and later became chairman of the board of a private bank in Vietnam. He was a founding member since 1988, a vice-chairman and then the chairman of IT Association of Vietnam from 1993 to 1999. He was founding member and director of Institute of Development Study, an independent policy research organization in Vietnam since 2007 until its desolution to protest government measures restricting works of independent policy research organizations in 2009. Guoguang Wu, Ph.D., is Professor in the Department of Political Science at the University of Victoria, Canada, and concurrently Professor in the Department of History and Chair in China & Asia-Pacific Relations at the Centre for Asian Pacific Initiatives at the same university. He specializes in comparative politics, global/comparative political economy, and the Global South (China, Hong Kong, Taiwan). His primary research interests follow two tracks: political economy of capitalism, and Chinese politics in comparative perspectives. Central to the first track is institutional reconfiguration of capitalism by globalization, which involves global dynamics of capital-laborconsumption interactions, changes in state-market relations, and global capitalism's dependence on effective authoritarianism. The second track covers the themes and aspects including political legitimacy; elite politics; mass media, the Internet, and political communication under authoritarianism; and, more generally, transitions from and democratization of communism and authoritarianism. He also does research in the fields of international politics (human security and global governance, China's post-Cold War foreign relations, East Asian regional international relations, Sino-U.S. relations, and China-Taiwan relations) and history of twentieth-century China (political, diplomatic, and intellectual histories, especially since 1949). Professor Wu has gained a Ph.D. in politics from Princeton University (1995), and has been the recipient of the Niemen Fellowship from Harvard University, Luce Fellowship from Columbia University, An Wang Post-Doctoral Fellowship from Harvard University, Visiting Professorship from the National University of Singapore, and a number of grants from the Social Sciences and Humanities Research Council (SSHRC). He taught at the Chinese University of Hong Kong before joining the University of Victoria in 2004. He is now on the editorial board of a dozen of

academic/intellectual journals and research/education institutions based in China, France, Hong Kong, India, Japan, Singapore, Taiwan, UK, and USA, respectively. Before the academic career, he was a journalist in China and involved in national policy-making on political reform in the capacity of a policy advisor and speechwriter to China's Premier Zhao Ziyang. He is the author of four books, which include two major research monographs: Globalization against democracy: A political economy of capitalism after its global triumph (Cambridge University Press, 2017), and China's Party Congress: Power, legitimacy, and institutional manipulation (Cambridge University Press, 2015). He is the editor or a coeditor of six scholarly volumes, all through the publisher of Routledge, and the latest ones are: Gender dynamics, feminist activism ad social transformation in China (coedited with Yuan Feng and Helen Lansdowne, 2019), China's transition from communism - New perspectives (coedited with Helen Lansdowne, 2016), and China's challenges to human security: Foreign relations and global implications (2013). His research articles are published in refereed journals including Asian Survey, China Quarterly, Comparative Political Studies, Journal of Chinese Political Science, Journal of Contemporary China, Pacific Review, Social Research, and Third World Quarterly. He also contributed a few dozens of chapters to academic collections. He has also extensively published in the Chinese language, with the outcomes of seven single-authored and three coauthored books, six edited volumes, and numerous articles. Emile Kok-Kheng **Yeoh**, Ph.D., founder and editor of the Scopusindexed triannual academic journal *Contemporary Chinese Political Economy and Strategic Relations: An International Journal (CCPS)* published by the Institute of China and Asia-Pacific Studies of Taiwan's National Sun Yat-sen University, is an Associate Professor at the Department of Administrative Studies and Politics, Faculty of Economics and Administration, University of Malaya, Kuala Lumpur, Malaysia. He holds a Ph.D. on ethnopolitics in socioeconomic development from the University of Bradford, West Yorkshire, England (1998), was the department head of the Department of Administrative Studies and Politics, Faculty of Economics and Administration, University of Malaya, from 1st August 2016 to 31st July 2018, the director of the Institute of China Studies, University of Malaya, from 13th March 2008 to 1st January 2014, the founder and editor of the institute's then SJR top-tier Scopus-indexed triannual academic journal, International Journal of China Studies (Vol. 1, 2010 – Vol. 5, 2014), and is currently a member of the international editorial committee of several journals in Asia and Latin America.
